Pledge of Allegiance

Mayor Spencer read Ordinance 2025-O-3

ORDINANCE 2025-O-2 - AN ORDINANCE OF THE TOWN OF GREENSBORO ADOPTING A GENERAL BUDGET AND ENTERPRISE BUDGET FOR THE FISCAL YEAR BEGINNING ON JULY 1, 2025 AND ENDING JUNE 30, 2026, AND ESTABLISHING A TAX RATE FOR THE FISCAL YEAR IN THE AMOUNT OF \$0.68 PER \$100 OF ASSESSED REAL PROPERTY VALUE; \$1.513 PER \$100 ON ALL COMMERCIAL OR BUSINESS PERSONAL PROPERTY; AND \$1.40 PER \$100 ON PUBLIC UTILITIES; AND TO ADOPT THE SERVICE CHARGE ON THE SECOND SEMIANNUAL TAX PAYMENT AND AN ADMINISTRATIVE FEE ADOPTED BY CAROLINE COUNTY

Commissioner Brelia to sponsor Ordinance 2025-O-3

Mayor Spencer noted the following:

- The current year tax rate was lowered from .70 to .68
- This year's budget went up \$33,544 (revenue), which is about 2%
- We have not added any new positions
- Each employee will receive a COLA raise of \$2000
- We have implemented in the budget for a third Police Officer
- We are not increasing the water/sewer rates
- We are not increasing Goldsboro rates
- Renewal of trash contract with Bigg Tyme Trash
 - Monthly – Town would pay \$14,300.91
 - Annually – Town would pay \$171,610.92
 - The cost covers all land fill expense as it's been for the past three years
 - Trash is not being raised for residents, and the Town covers \$29,248.92 that is not collected from residents.

- Susquehanna – The contract is for three years and has increased for year two by \$5,112 for a yearly total of \$260,436.00

Motion made by Commissioner Harrison to adjourn the meeting which was seconded by Commissioner Robinson at 6:09 pm.
