- FY23 Audit moving forward, should be completed by 12/31/2025. FY24 and FY25 will be working on auditing to complete them simultaneously and completed by 6/30/2026.

- Every utility account is being audited for accuracy. Town of Goldsboro will resume their billing of their Sewer effective 1/1/2026. Town will continue to bill for County Sewer.

#### **11. Council Remarks**


- Council members expressed their enthusiasm for the upcoming projects and thanked the community for participation during the elections.
